Financial Report

Monthly Financials

Old Business

Dawn reported that she had an incident with one of the dogs not being on a leash and running toward her. The Board discussed the attorney's recommendation of pre-suit mediation. Dawn made a motion, which was properly seconded by Patrick, to proceed with the pre-suit mediation. Motion passed unanimously.

Kim called Frances and asked about her shrubs. Frances stated that she had not planted them. Kim will contact her and ask she will have to remove them or she can authorize us to remove them.

New Business

Pool

The Board discussed the quote received for repair of the coping at the pool. Dawn made a motion, which was properly seconded by Patrick, to approve the quote for the coping repair. Motion passed unanimously.

Lawn

Patrick reported his frustration and recommend the Board seek another quote for lawn maintenance. David reported that he had reached out to Wallace for a quote.
